Applications are invited online only by One Time Registration system exclusively from qualified candidates belonging to reservation group of communities of Kerala State viz SC, Viswakarma, Muslim for NCA vacancy for selection to the under mentioned post.

Note : Differently abled candidates and women candidates are not eligible to apply for the post.

(This is the Second NCA Notification owing to the paucity of the candidates relating to SC, Viswakarma & Muslim Communities in the Ranked List published on 24.02.2014 for the above post in response to the notification published in the Gazette dated 30.04.2011 Cat. No. 74/2011)

Notes:

- (i) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.

- (ii) Ranked list will be prepared for each community in Thiruvananthapuram unit in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in the following unit as detailed below.

- (iii) The candidates should note the name of the concerned unit against the relevant column of the online application.
- (iv) The selection in pursuance of the notification will be made on unit basis, subject to the special conditions laid down in G.O. (MS) No 92/80/Home dated, 24.09.1980. A candidate advised for appointment in one unit from the Ranked List prepared is not eligible for transfer to another unit unless he completes five years continuous service from the date of commencement of service in the former unit. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD dated 02.1.1961. Candidates already in Government service holding this post in any one unit are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (Only from candidates belonging to communities mentioned above)
6. Age : **Viswakarma & Muslim** - 18-39. Candidates born between 2.1.1976 and 1.1.1997 (both dates included) are eligible to apply for this post. (Including age relaxation specified in Para 2 (i) of the General Conditions)
- Scheduled Caste** - 18-41. Candidates born between 2.1.1974 and 1.1.1997 (both dates included) are eligible to apply for this post. (Including age relaxation specified in Para 2 (i) of the General Conditions)

Note :- For other concessions allowed in upper age limit, the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification except para 2(i)

7. Qualifications:

- (1) **Pass in SSLC or its equivalent examination.
Rule 10 (a) (ii) of KS & SSR is applicable.**
- (2) (i) **Must possess physical fitness as specified below:-
Must be at least 165 cm height and must be 81.3 cms
round the chest on full expiration and must have chest
expansion of at least 5 cms.
(For SC candidates minimum height required is 160
cm.)**

Note:

- (a) Other qualifications being equal, the Home guard Volunteers who have completed the term of 3 years in that organisation and who have undergone training during the period of tenure satisfactorily, will be treated as having additional or desirable qualification.
- (b) Proficiency in Sports, Military Training and Membership in National Cadets Corps will be considered as additional qualification.

(2) (ii) Physical Efficiency Test :-

Candidates will be subjected to a Physical Efficiency Test and must qualify themselves in the following events namely:-

(1)	100 Meters Run	:	14 seconds
(2)	High Jump	:	132.2 cm (4' 6")
OR			
	Long Jump	:	457.2 cm (15')
(3)	Rope Climbing (by using hands only)	:	365.8 cm (12')

Note:

The physical measurement of candidates will be taken at the time of physical efficiency test and those who do not possess the prescribed physical measurement will not be admitted for the physical efficiency test. If accidents or injuries happen to a candidate while participating in the physical Efficiency Test, he will not be given further chance to participate in the test.

3. **Visual Standards:** All candidates must possess the visual standards specified below without glasses

(c)	Each eye must have full field of vision. Colour blindness, squint or any other morbid condition of the eyes or lids of either eye will be deemed to be a disqualification		
(d)	Must be free from apparent physical defects like knock – knee, Flat Foot, Varicose veins, Bow Legs, Deformed limbs, Irregular and Protruding Teeth, Defective Speech and Hearing		

Note : Candidates should produce at the time of Physical Efficiency Test a Medical Certificate in original in the form prescribed here under certifying to their physical fitness and eye sight without glasses. The Medical Certificate should be one obtained from a Medical Officer not below the rank of an Assistant surgeon/Junior consultant and upload the same in their profile at the time of verification of certificates.

Details regarding standards of vision should be clearly stated in the certificate, as given above and vague statements such as vision 'Normal', 'Average' etc. will not be accepted. Specification of each eye should be stated separately against each item. If the Specifications are not as indicated above, the officer issuing the certificate should notify whether the candidate has got better standards of vision or worse standards of vision, as the case may be, otherwise the certificate will not be accepted.

8. Mode of submitting applications:-

Candidates must register as per “ONE TIME REGISTRATION” system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' . Those who have registered shall apply by logging on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details on the registration card by clicking the link **Registration Card** after entering the home page. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile and they shall keep in mind the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected.

Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
