### **THIRD NCA NOTIFICATION**

Applications are invited online only by One Time Registration from qualified candidates belonging to Scheduled Caste reservation group of community of Kerala state viz Scheduled Caste for selection to the under mentioned post.

1. Department : Education
2. Name of post : Full Time Junior Language Teacher (Arabic) – UPS
3. Scale of pay : ₹ 11,620-20,240/-
4. Number of vacancies : District wise

Scheduled Caste - Kollam- 2 (Two)

Re-notification for the post notified as Category No.128/2011 in Gazette dated 31.05.2011 and Category No. 190/2013 in the Gazette dtd. 29/6/2013.

Note :-

- (i) Conventional type applications will be summarily rejected. Candidates shall apply online only to [www.keralapsc.gov.in](http://www.keralapsc.gov.in).
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to such candidates.
- (iii) Ranked list will be prepared for Kollam district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (v) Application shall be sent to Kollam district only in response to this notification and the name of the district shall be noted in the relevant column of the application.

**5. Method of appointment :** Direct Recruitment (from the candidates belonging to Scheduled Caste community only). In the absence of Scheduled Caste candidates belonging to Scheduled Tribe candidates will be considered.

**6. Age Limit** 18-45. Only candidates born between 02.01.1970 and 01.01.1997 (Both dates included) are eligible to apply for the post. [Including the relaxation as per Para 2(i) of General Conditions].

Note : For concessions regarding other age relaxation please see para 2 of the general conditions. Except para 2 (i) subject to the condition that the maximum age limit shall in case exceed 50 (fifty) years.

**7. Qualifications:-**

A Degree in Arabic conferred or recognized by the Universities in Kerala.

OR

A Title of Oriental Learning in Arabic awarded or recognized by the Universities in Kerala.

OR

A pass in S.S.L.C. Examination, Kerala or its equivalent and a pass in Arabic Munshi Examination (Higher) conducted by the Commissioner for Government Examinations, Kerala.

OR

(a) A pass in SSLC Examination Kerala or its equivalent, and

(b) A pass in Arabic Teachers Examination conducted by the Commissioner for Government Examinations Kerala.

OR

Arabic Preliminary Examination of the Kerala or Calicut Universities.

OR

Pass in Pre-Degree Examination in Part III Arabic (Special Optional) from the Calicut University.

Note:- Rule 10 a (ii) of Part II KS & SSR will be applicable to this post.

**8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT**

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Wives of Jawans should select 'Are you entitle to any priority' as 'yes' on online application and give the details in the space that follows. Such candidates should obtain proper certificates from the Officer Commanding stating the

name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).

- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975) .

Note: The candidates who claim concessions by virtue of above or any of the reason mentioned in Para 2 of the General Condition should select “Are you eligible for age relaxation” as “yes” on the online application and give details in the space following otherwise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (see para 2 of General Conditions).

9. Mode of Sending Application :

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
