The above vacancies are now in existence. This is the Second NCA Notification for the post due to the non-availability of qualified candidates belonging to above communities as per the First NCA notification, Gazette dated 15.03.2014.(Cat. No.39/14 & 41/14.)

- 5 Method of appointment :: Direct Recruitment (from candidates belonging to Dheevera & Hindu Nadar communities only)

Note:- Applications submitted by candidates belonging to communities other than the above mentioned communities will be summarily rejected. Individual communication regarding rejection of their application will not be issued.

- 6 Age limit : 19-39. Only candidates born between 02.01.1976 and 01.01.1996 (both dates included) are eligible to apply for the post. (including relaxation as per para 2(i) of the General Conditions.) [For other conditions regarding age relaxation please see para 2 of the General Conditions except para 2(i).]

- 7 Qualifications :

- 1) Must possess a Bachelors Degree in Forestry of the Kerala Agricultural University or any other recognized University of India.

OR

A Degree from the Indian Institute of Forest Management.

Note:- Rule 10 (a) ii of Part II of KS&SSR is applicable.

- 2) Must have the following Physical Measurements.

For Male Candidates:

Height : 163 cms

Chest : 79 cms

Normally with a minimum expansion of 5cms of full inspiration.

For Female Candidates:

Height : 150 cms

Chest : 74 cms

Normally with a minimum expansion of 5cms of full inspiration.

Note:- Persons recruited direct to the Category of Rangers shall undergo practical training for a period of one year in the Forest Department prior to their appointment as Rangers. The period spent on practical training in the Department will not count for probation, leave, increment, pension, etc. During the period of practical training, trainees will be eligible for a monthly allowance at such rate fixed by Government from time to time.

8. Mode of submitting applications :-

Before applying for the post, candidates shall register as per 'ONE TIME REGISTRATION' through the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in'. Those who have already registered shall apply by logging in to their profile using his/her User-ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. The photograph uploaded should be one taken on or after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs No application fee is required. Candidates can view, rectify defects and have print - outs of the details in the Profile by clicking the link Registration Card after entering the Home Page. . Candidates are responsible for the correctness of the personal information and secrecy of password and they must quote the User ID for further communication with the Commission. Before the final submission of application on the profile, candidates must ensure the correctness of the information on their profile. Applications once submitted will be received as provisional and the particulars shall not be deleted or altered after submission. Applications which are submitted not in accordance with the instructions given on the notification and website will be summarily rejected. Documents to prove qualification, service, age, community etc. have to be produced as and when called for.
