GENERAL RECRUITMENT – DISTRICT WISE

Applications are invited online only by 'One Time Registration' from qualified candidates for the under mentioned post.

1. Department : SAINIK WELFARE
2. Name of Post : Welfare Organiser (Ex-Servicemen only)
3. Scale of pay : ₹ 13,900 – 24,040/-
4. No. of vacancies : District wise

Notes :

- (i) Candidates shall apply only through online facility available in the Kerala Public Service Commission website viz www.keralapsc.gov.in. Conventional type applications for the post will be summarily rejected. No rejection memo will be issued.
 - (ii) The ranked list prepared and published by the commission in pursuance of this notification shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list.
 - (iii) The selection in pursuance of the notification will be made on a revenue district basis subject to the special conditions laid down in GO (MS) No.154/71/PD dated 27/05/1971. A candidate advised for appointment from the Ranked List prepared in one revenue district is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O. (P) No. 36/91/P&ARD, dated 02.12.1991 for inter district transfers. Candidates already in Government service holding this post in any district are prohibited from applying in response to this notification.
5. Method of appointment : Direct Recruitment (Ex servicemen only)
 6. Age : Should not have completed 50 (Fifty) years of age including Military service as on 01.01.2015.

For conditions regarding other age relaxation, please see para (2) of the General Conditions under Part II of this Notification except para 2(i) and(vi).

Notes:-

- (i) Relaxation in upper age limit will not be allowed to this post.
- (ii) Attested true copies of the military Discharge certificates should be produced as and when called by the Commission.
- (iii) Candidates who are selected for appointment as per this notification should not have completed 56 years of age while joining duty.

7. Qualifications :-

Pass in SSLC or its equivalent.

Candidates should be ex – Junior Commissioned Officer in the Army or Ex-servicemen of equivalent rank in Navy or Air Force.

KS&SSR Part II Rule 10(a) (ii) is applicable for selection to the post.

8. Mode of submitting applications:-

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
