SECOND NCA NOTIFICATION

Applications are invited online only by One Time Registration scheme exclusively from qualified candidates belonging to reservation group of SC community of Kerala State for NCA recruitment to the under mentioned post.

1. Department : **NCC/Sainik Welfare Department**
2. Name of post : **Last Grade Servant (Ex-servicemen only)**
3. Scale of pay : ₹ 8,500 - 13,210/-
4. Number of vacancies : Community wise
Kollam – SC - 02 (Two)

Notes :

- (i) Conventional type applications will be summarily rejected. Candidates shall apply only through online facility available at the Kerala Public Service Commission website viz www.keralapsc.gov.in.
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. In the absence of candidates belongs to SC community applications of ST will be considered.
- (iii) A Ranked list will be prepared for above district in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in the following district as detailed below.

- (iv) This is the second NCA Notification issued for the SC Community since candidates were not available in response to the I NCA Notification published in the Gazette dtd 31.12.2013 as category No 637/2013
- (v) The candidate belonging to above reservation community shall submit application for the post to Kollam District where the vacancy is existing for their communities and shall note the name of the district against the relevant column of the online application.
- (vi) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district

from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- vii) In addition to the post of Peon and Chowkidar, Posts of Lascar Watchman etc earmarked for Direct recruitment as per the amendment in GO.No. 475/78/GAD dtd. 17.10.1978 for Last Grade Service Special rules, will also be considered.
5. Method of appointment : Direct Recruitment (From candidates belonging to SC community only).
6. Age : 18-50. Candidates born between 02.01.1966 and 01.01.1998 (both dates included). (Including Military Service and other benefits mentioned at para 2 of the General Condiditons under Part II of this notification)
7. Qualifications :-
- (i) Must be able to read and write Malayalam or Tamil or Kannada.
- (ii) Must be an Ex-servicemen.

Note:- Rule 10 (a) ii of part II of KS & SSR is applicable.

- (1) Differently Abled candidates and female candidates are not eligible for appointment to the post of Watcher, Night Watcher, Watchman, Night Watchman and Lascar.
- (2) Candidates from the Ranked List prepared in response to this notification will be advised for appointment as per turn against Head Quarter vacancy also.
8. Last date of receipt of applications : **31.08.2016 Wednesday upto 12 midnight.**
9. Mode of submitting applications:-

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance

with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.

10. Address to which applications are to be sent : www.keralapsc.gov.in.
11. If a Written Test/OMR/Online Test is conducted as a part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
